Motion made, seconded and passed to accept the Minutes from January 8, 2019

Debbie Britland, Treasurer

- Balance as of January 31, 2019 was \$16,664.77
- Balance does not reflect the \$5,000.00 or \$1,000.00 checks to be disbursed to Home Place of Texas

- Consensus is that members enjoyed having the tables set up for the meeting
- Will have one row of chairs near the stage
- No charge for coffee for the March meeting to make up for the fact that it was provided late for the February meeting
- Passed around sign-up sheet for tables required for March meeting
- Linda Nagel expressed how wonderful the programs have been this year
- Many of the suggestions came from the membership

Sue Behnke (for Tracy Lalor, Membership)

- Board has approved providing all Activity Leaders with packets containing membership forms to be distributed to activity participants. Forms are to be filled out and returned with membership dues to the Activity Leaders, who will turn them over to Tracy Lalor or a member of the Membership Committee (or if necessary to any of the Board members, who will get it to the Membership Committee)
- Margaret Burgess and three other activity leaders have expressed their opposition to the "requirement" of Activity Leaders to this method of collecting dues
- This method will be on a one-year trial basis to ascertain if it is beneficial for continuation
- Sherry Dunn expressed that this would be helpful to the Membership Committee, as collecting from many members who do not attend General Meetings and participate only in activities is sometimes difficult as well as members who do not attend the General Meeting and only participate in FAN activities
- Cissie Alexander expressed that it should be the Board's responsibility to contact members who are not current in the payment of their dues

- Membership drive will start in March with the distribution of packets to Activity Leaders (FAN membership year begins June 1)
- Completing the Membership Form is extremely important to coordinate access of information to the Membership Committee, the Board and the Nominating Committee, as well as information for the Directory
- Discussion as to those who cannot afford to pay dues should be handled on a case-by-case basis
- Suggested that all members of the Board have their dues and forms in at or prior to the General Meeting as a show of encouragement to the members
- It was also suggested that the Activity Leaders be recognized at the March meeting in an effort to coordinate Membership and Activities
