    - 151 paid guests @ \$5.00 donation each: \$755.00
    - 151 paid guests @35 (food and fees at Northgate): \$5,285.00
  - Total expenses: \$5,421.34
    - Expenses from budgeted \$1,500: \$341.34
    - Northgate Deposit for facility rental: \$500.00
    - Northgate Invoice for Luncheon: \$4,580.00
  - Net revenue over expenses: \$4,745.66
